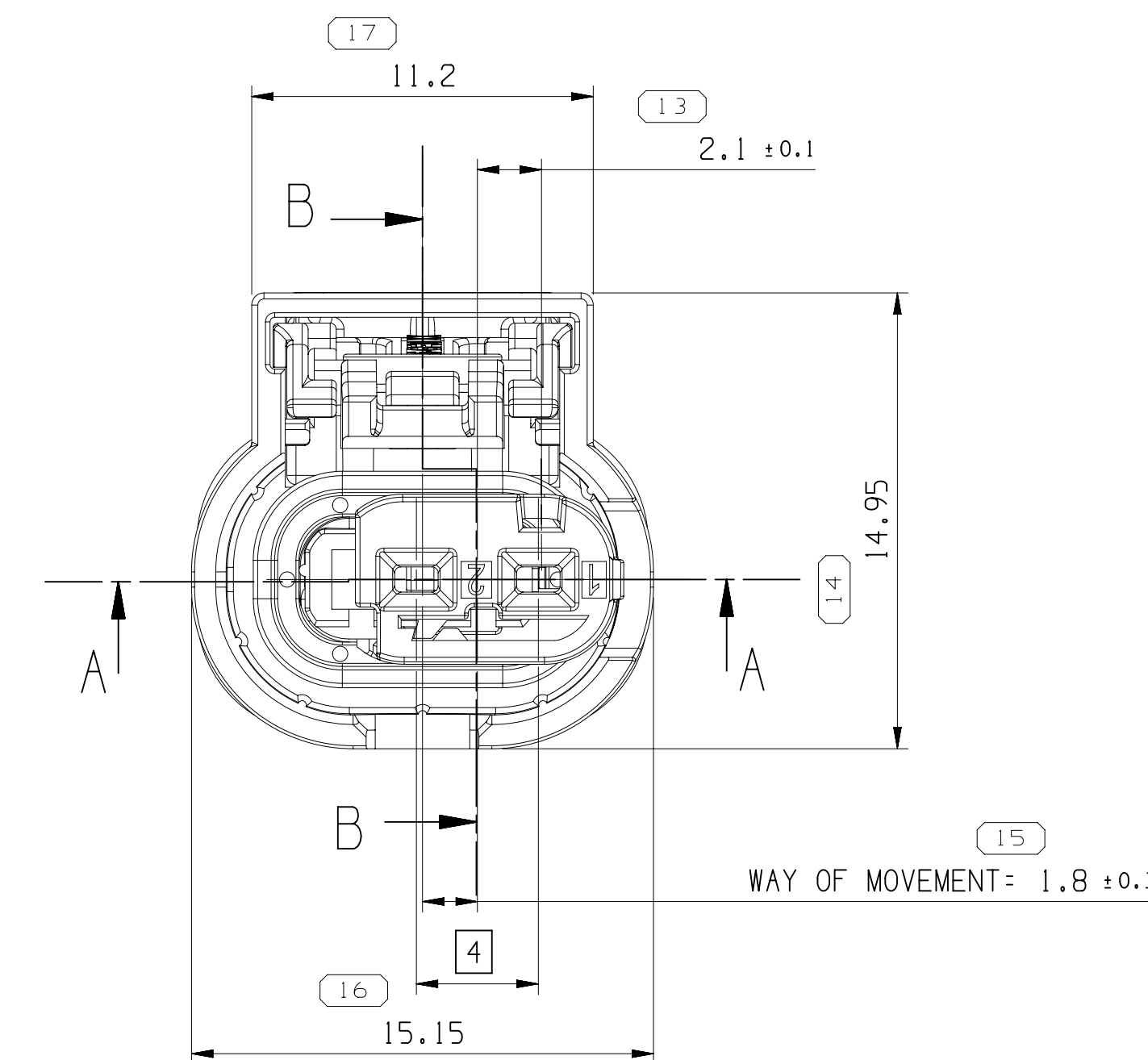
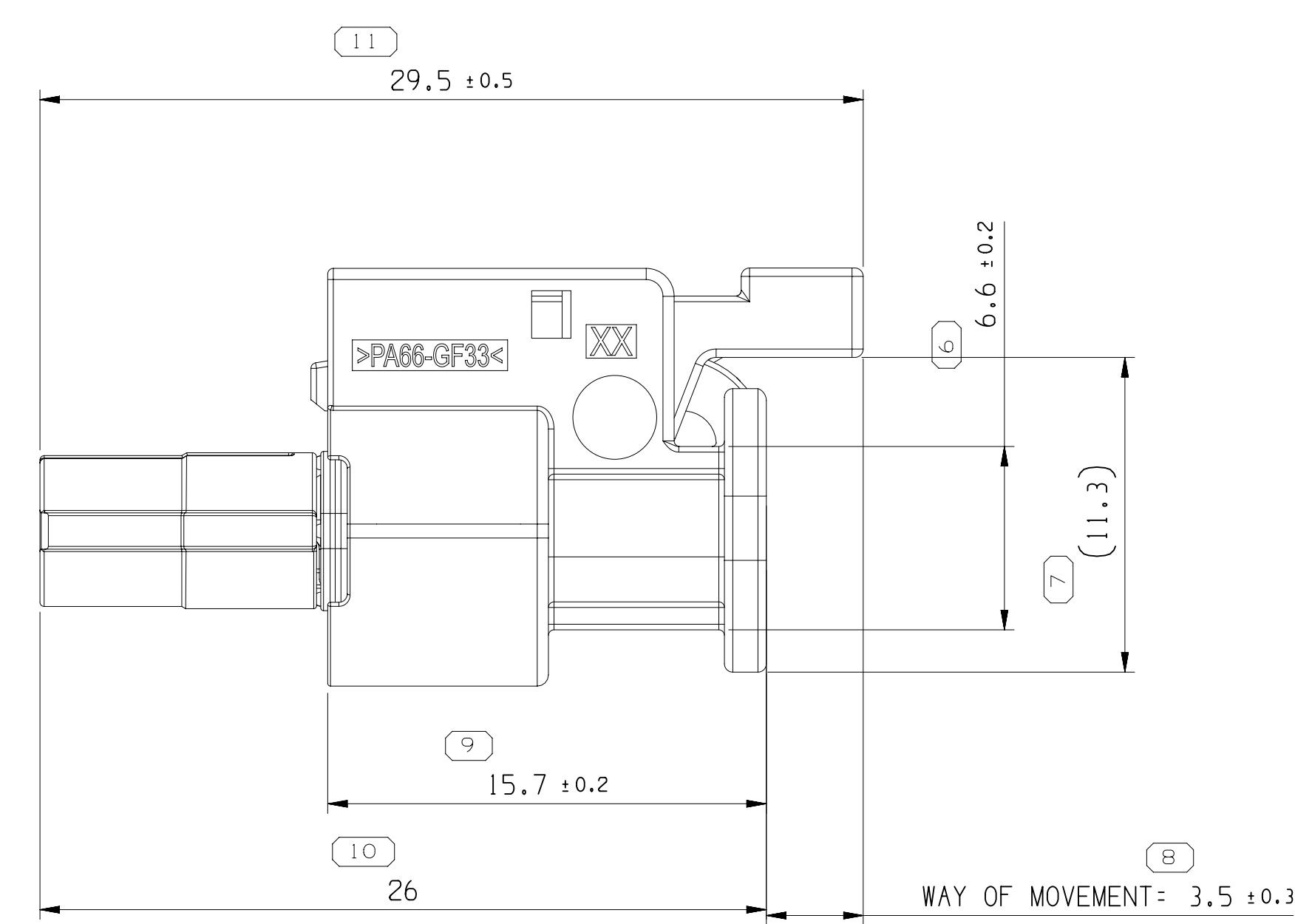
TPA AND CPA FINAL LOCK POSITION



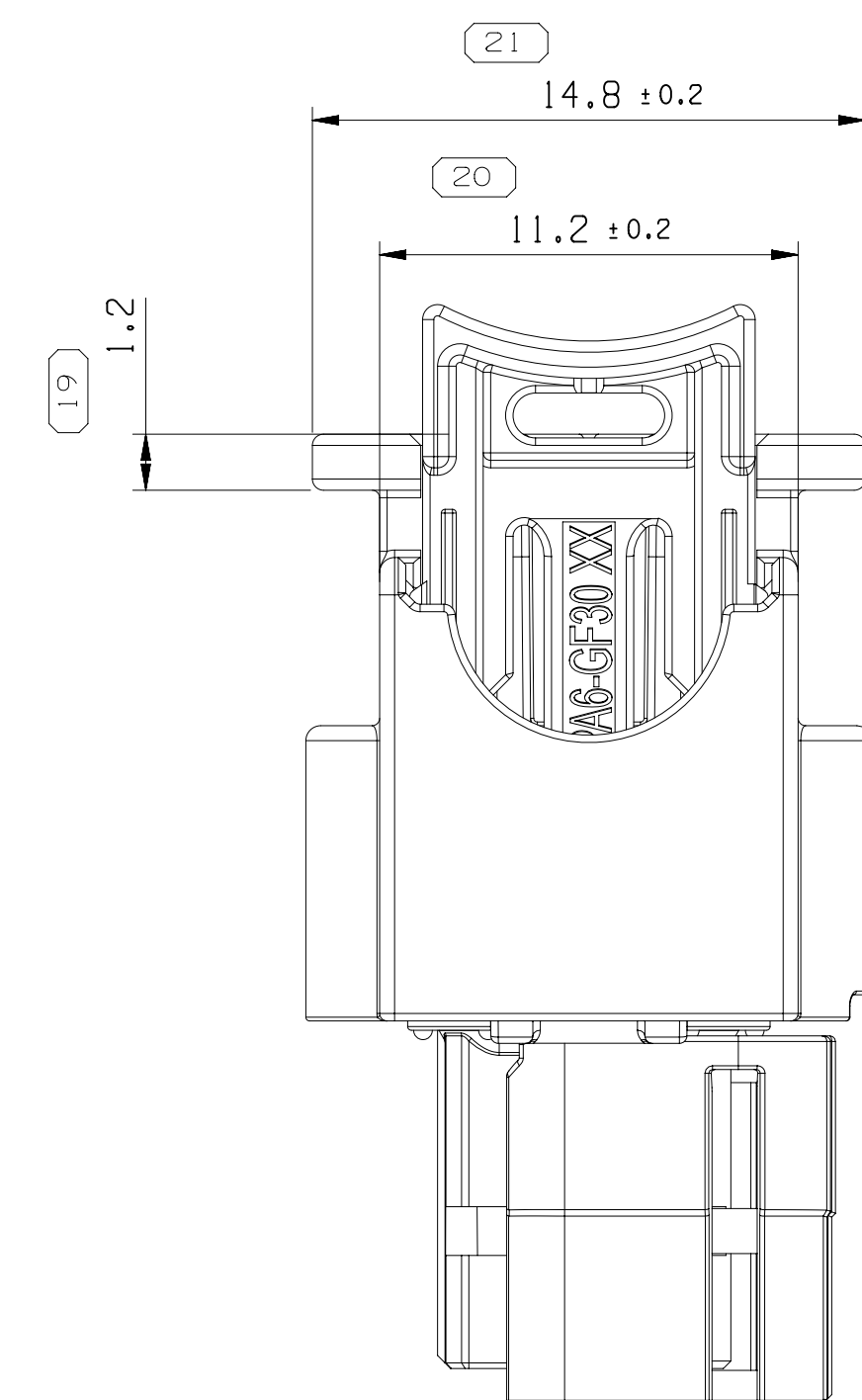

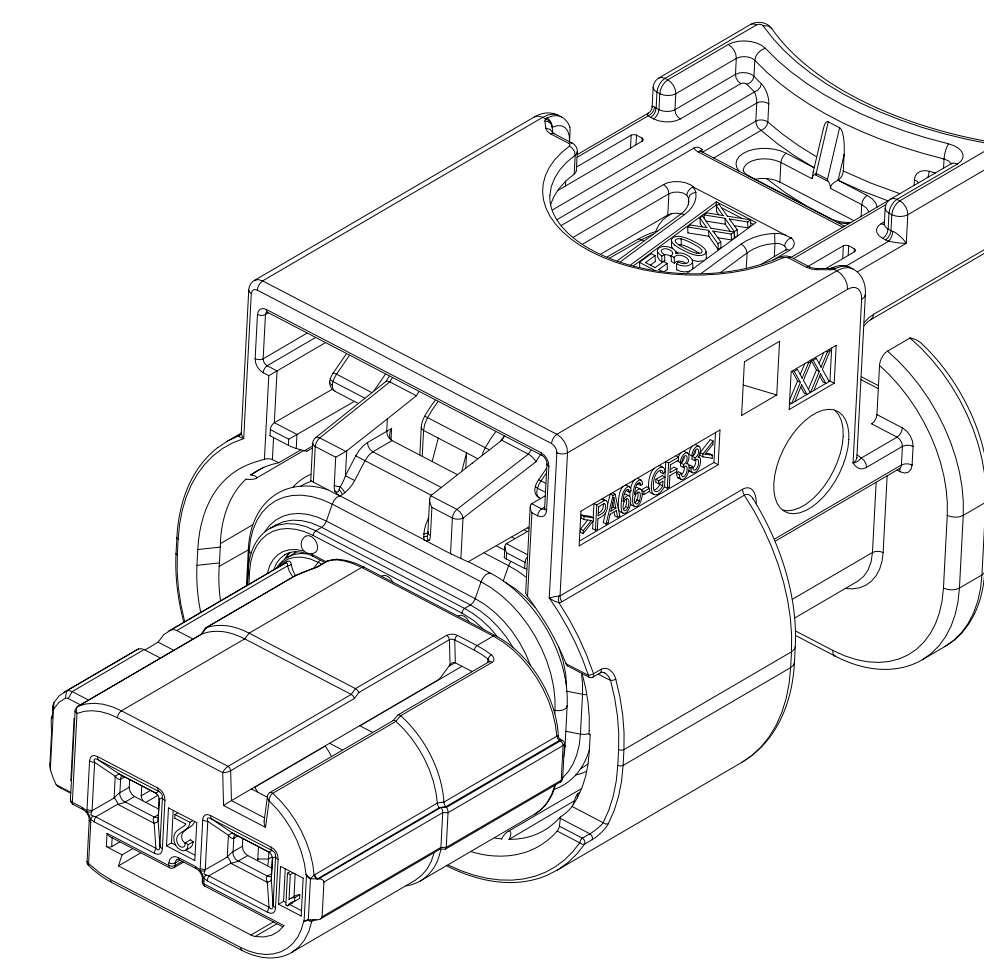

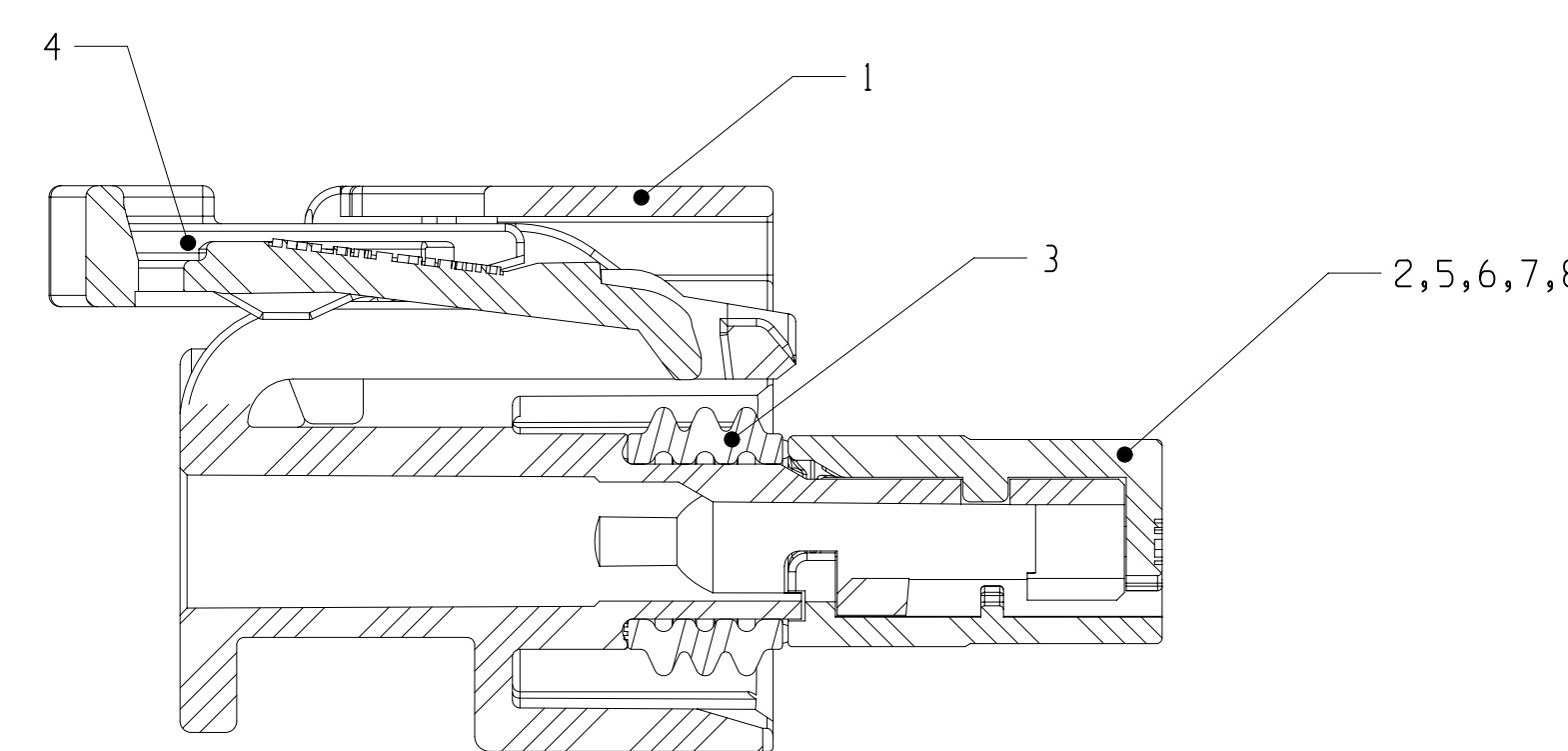
